Introduction

This Privacy Policy sets out how we collect, use and protect the personal information of our members (candidates), partners, clients, other stakeholders, and or all who choose to use our website, or any other platforms provided by TheBoardroom Africa (TBrA). Subscriber: an individual that has subscribed to TBrA marketing materials, including our Newsletters, online publications, and other content delivered electronically

Information We May Collect About You:

We may collect and process the following data:

Information you give to us

You may give us information about you by filling in forms (e.g. our 'Member Profile Form'), by contacting us via email, letter or telephone, by subscribing to our newsletter or by submitting a CV or other biographical information about yourself.

The information you give to us may include, but not limited to:

- your name and title;
- contact information, including telephone number and email address;
- information such as postcodes, and your preferences and interests; and employment details including and not limited to board service, date of birth, employment history, qualifications, etc.

Information we collect about you on our website

Each time you visit our Website, we may automatically collect the following information:

- for information, including sending details about TBrA's offering, newsletters, Board related events and events targeting senior executive women, seminars and updates.

- to ensure that our Website's content is presented in the most effective manner for you and your computer;
- to customise the Website according to your interests;
- to administer the Website and for internal operations, including troubleshooting, data analysis, testing, research, statistical and survey responses;
- to allow you to participate in interactive features of our service when you choose to do so;
- as part of our efforts to keep the Website safe and secure;
- to measure or understand the effectiveness of information we provide to you and others, and to deliver relevant information to you;
- to comply with the law;
- as we feel is necessary to prevent illegal activity or to protect our interests.

Disclosure of Your Information:

We will share your personal information within TheBoardroom Africa, and where required, with third parties, your information will not be shared with third parties without your prior consent.

When we share your information with third parties they will process your information as either a data controller or as our data processor and this will depend on the purposes of our sharing your personal data. We will only share your personal data in compliance with the applicable data protection legislation.

We may disclose your information to third parties when:

- you specifically request this, such as when you submit information to enquire about suitable Board positions or submit applications via email or other TBrA managed online platforms;
- you indicate your willingness for us to share your profile as part of our service to promote you amongst your peers and potential clients
- if we are under a duty to disclose or share your personal data in order to comply with any legal obligation or to protect the rights, property or safety of the Website, our customers, or others.

The third parties include:

- business partners, clients, suppliers and sub-contractors for the performance of any contract we enter into with them or you; and analytics and or online license providers that assist us in the improvement and optimisation of the data.

We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy.

We follow strict security procedures as to how your personal information is stored and used, and who sees it, to help stop any unauthorised person getting hold of it. All personal information you register with us by using our services or our Website will be located behind a firewall. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.
